

Rental room terms of use

These Terms of Use stipulate the matters that customers must strictly adhere to when using the rental room. You can use our rental room by agreeing to these terms of use. If you do not agree to the terms of use, you cannot use our rental room. In addition, if you violate the terms of use, you will be immediately suspended from using the rental room and will be charged a penalty fee.

1. Matters regarding use

(a) Reception hours

(b) Usage fee

first hour	Every hour thereafter	maximum charge

Banquet fee : one person : ¥500 (2h)

※Banquet use is for 3 or more people (2 rooms are for 6 or more people)

(c) Payment method

Payment is required in advance.



2. Safety matters

(a) Prohibition of the use of fire (notice of complete **no smoking** in the facility)

To prevent fires, the use of open flames (including cigarettes and electronic cigarettes) is prohibited indoors. I will do it. Also, smoking by leaning out of the window is strictly prohibited.

(b) Refusal to use the facility while intoxicated

Customers are not permitted to use the facility while intoxicated (as determined by the staff) as this may cause injury or trouble to themselves. In addition, excessive drinking (to the point of becoming intoxicated) while using the rental room is prohibited.

3. Ethics matters

Please strictly adhere to the following matters while using the rental room. If any of the following actions are discovered, please immediately report and stop using the service, and you will be prohibited from using any of our services in the future.

- (a) Criminal acts (drug inoculation, peeping, stealing, theft, etc.) are prohibited inside the store.
- (b) Disturbing behavior while using the facility (loud conversations, watching TV at high volume, etc.) is prohibited.
- (c) **Prohibition of entry into restricted areas. (Suspicion of home invasion)**
- (d) Criminal acts (cyber attacks, fraud, etc.) while using our store's Wi-Fi

4. Matters regarding damage to equipment

If you damage any of the equipment managed by our store (home appliances such as televisions, furniture, shoji screens, etc.), please immediately report it to a store staff member. The customer will be responsible for all repair and purchase costs for equipment.

※Damage includes not only equipment that is damaged but also soiled.

5. Regarding injuries such as in-store injuries

The store is not responsible for any injuries that occur in the store if the customer is at fault. You will be responsible for paying your own treatment and hospitalization costs.

Example)

- I fell down a step or stairs in a store.
- I got my finger caught in a door or a sliding door.
- Feeling unwell due to heat stroke.

6. Matters regarding reservations

- (a) Cancellations due to customer convenience (excluding unavoidable cases such as illness) will be cancelled. A cancellation fee will be charged. Please transfer the amount to the account specified by our store within one week of the reservation date. **The day before: 50%** of the fee. **On the day: 100%** of the fee.
- (b) If you come to our store or pick up your order within 30 minutes after your reservation time without prior notice. If not, we will cancel your reservation without exception. Cancel in that case as well. There will be a fee.

privacy policy

Our company has established the following privacy policy regarding the handling of personal information acquired by our company, and will comply with the Act on the Protection of Personal Information, guidelines on the protection of personal information, and other relevant laws and regulations regarding the protection of personal information.

【1. personal information】

"Personal information" refers to personal information as defined in the Personal Information Protection Act, and refers to information about a living individual that can identify a specific individual based on the name, date of birth, address, telephone number, contact details, and other descriptions contained in the information, as well as data related to appearance, fingerprints, voiceprints, and information that can identify a specific individual from the information alone, such as the insurer number on a health insurance card (personal identification information).

【2. Safety management of personal information】

With regard to the protection of personal information, our company will implement appropriate organizational, physical, personnel and technical measures, and will take necessary and appropriate measures to prevent the leakage, loss or damage of personal information handled by our company, and to otherwise safely manage personal information.

【3. Purpose of Use of Personal Information】

Except as required by law or with the consent of the individual, we will not use the personal information we acquire beyond the scope necessary to achieve the purposes of use set out below.

- ① Operation, maintenance, and management of this website
- ② Provision and introduction of services through this website
- ③ Surveys to improve the quality of this website

【4. Disclosure and correction of personal information】

Except as required by law, we will not provide personal information acquired with the consent of the individual to a third party without the individual's prior consent. Furthermore, with regard to requests for disclosure, correction, addition or deletion of personal information, or notification of the purpose of use, we will do so in accordance with the law, and will respond appropriately to any opinions or inquiries.

【5. Change in purpose of use of personal information】

In principle, we will not change the purposes of use specified in the previous section unless we have received the prior consent of the individual. However, this does not apply when we make changes to the purposes of use after publicly announcing them in advance, to the extent that they are reasonably deemed to be related to the purposes of use before the changes.

【6. Provision of personal information to third parties】

When the Company entrusts all or part of the handling of personal information to a third party, the Company will thoroughly examine the suitability of the third party and provide necessary and appropriate supervision of the entrusted party to ensure the safe management of the entrusted personal information.

【7. Improvement and review of the handling of personal information】

Our company will inspect its handling of personal information, management system and initiatives, and will continually improve and review them.

【8. Deletion and disposal of personal information】

When personal information is no longer necessary in light of the purpose of use, the Company will erase or discard such information. Such erasure or disposal will be carried out in a necessary and appropriate manner to prevent risks such as leakage to outside parties, and only to the extent necessary for the performance of business.

【9. About SSL Security (Secure Socket Layer)】

Our website is compatible with SSL, which encrypts communication between the web browser and the web server. Personal information entered by users is automatically encrypted.

We make every effort to ensure the accuracy of the information on our website, but we assume no responsibility for any actions taken by users using the information on our website.

We assume no responsibility for any damage suffered by users as a result of their use of our website, or any damage caused by users to third parties.
